Dr K Giri Babu, Dean of Academics welcomed the JNTUK Nominees, Principal, Dean of Administration, Heads of the Departments and other Academic Council members.

Dr Y Mallikarjuna Reddy, Principal presented the Academic Report of 2020-21 and the members approved it. He expressed his happiness about the sanction of new programme B.Tech- Artificial Intelligence and Machine Learning (AI & ML) with an intake of 60 students and an increase in intake of students in existing B.Tech -CSE (AI & ML) (CSM) programme from 60 to 180. He also added the validity of NAAC accreditation that is extended up to 31/12/2024 with CGPA 3.09 and Grade A.

Dr K Giri Babu, Dean of Academics, presented the R&D activities of various departments indicating the funds mobilized from various funding agencies.

**RESOLUTIONS:**

**Item-1:** Approval of Minutes of the External Board of Studies Meetings for the Syllabus of III Year B. Tech programme of Autonomous batch under R-19 regulations.

**Resolution-1:** Heads of the Departments of CIV, EEE, MEC, ECE, CSE and INF programmes presented the minutes of their respective External Board of Studies Meetings held and the suggested syllabus for III Year B. Tech programmes for students of Autonomous batch under R-19 Regulations for the AY 2021-22. The Academic Council approved the same.

**Item-2:** Approval of Minutes of the External Board of Studies Meetings for Course Structure of all years of B. Tech programmes and Syllabus for First Year and Second Year B. Tech programmes for students of Autonomous batch under R-20 regulations.

**Resolution-2:** Heads of the Departments of CIV, EEE, MEC, ECE, CSE, INF, AID, CIC, CSM and CSO programmes presented the Minutes of their respective External Board of Studies Meetings held and the suggested course structure of all years of B. Tech programmes and syllabus for First year and Second year B. Tech programmes for students of Autonomous batch under R-20 regulations.

The council approved the Minutes of External Board of Studies meetings presented by the Heads of the respective programmes for suggested syllabus and curriculum for B. Tech programmes under R-20 regulations including honors/minor degree courses for Autonomous batch students admitted in AY 2020-21.

**Item-3:** Approval of Minutes of the External Board of Studies Meetings for syllabus of M. Tech programmes of Autonomous batch under R-19 regulations.

**Resolution-3:** The council approved the Minutes of External Board of Studies Meetings for syllabus of M. Tech programmes of Autonomous batch under R-19 regulations.

**Item-4:** Approval of Placement and Training Activities for the academic year 2020-21.

**Resolution-4:** Dr. K. Suresh Babu, Head, Training and Placement Cell presented statistics about the placements secured for the AY 2020-21, the plans for future roll outs and student training and the same was approved by the members.

**Item-5:** Approval of Results for the First Year and Second Year of B. Tech and M.Tech programmes under R19 Regulations.

**Resolution-5:** Dr P Ammi Reddy, Controller of Examinations, VVIT presented the Result Analysis of the following Autonomous batch of students under R19 regulations

1. B.Tech First Year II semester of 2019-20 batch
2. B.Tech Second Year I semester of 2019-20 batch
3. M.Tech First Year II semester of 2019-20 batch
4. M.Tech Second Year I semester of 2019-20 batch

Also he informed that there is a considerable delay in conducting the Semester End Examinations for students due to Covid-19 lock down and restrictions imposed on educational institutions. It was approved by the members.

**Item-6:** Approval of NCC training course offered as an elective course in the R20 Regulations from the AY 2020-21 as per the directions from UGC/AICTE.

**Resolution-6:** Academic Council approved the implementation of NCC training course as an elective course in the curriculum of R20 regulations from the AY 2020-21.

**Item-7:** Approval of the Course Structure and the Syllabus for minor degree course in CSE and IT.

**Resolution-7:** Academic Council has approved the Course Structure and the Syllabus for Minor Degree courses offered by the Departments of CSE and IT for the students of other departments with effect from Academic Year 2020-21.

**Suggestions:**

Dr. L. Sumalatha, JNTUK University Nominee, suggested that if theoretical assessment in Mid and end semester examinations is not planned for Skill based courses across the curriculum, it is preferable to have one theory hour assigned per week along with practical hours.

Dr. R. Srinivasa Rao, JNTUK University Nominee suggested that NCC authorities should not impose restriction on the number of students opting for that course as an elective programme. If the number is restricted there will not be proper justification for the students to select it. He also suggested that the Academic Council meeting should be held once in every six months.

**Responses:**

The Principal informed the Academic Council that the class work for First Year B. Tech programme for students admitted in AY 2020-21 under R-20 Regulations and Second Year B. Tech programme for students admitted in AY 2019-20 under R-19 Regulations started as per the AICTE and APSCH directives following the JNTUK guidelines for course structure and syllabus for Autonomous colleges. However, due to the Second wave of COVID-19 Pandemic and strict restrictions and lockdowns imposed on the educational institutions, there was an unusual delay in conducting the External Board of Studies Meetings.

The Principal also informed that Skill based courses will be assessed as a Lab-oriented practical courses with both Internal Practical Examination for 15 marks and External Practical Examination for 35 marks following the JNTUK guidelines.

The meeting ended with a formal Vote of Thanks by the Principal with a note of caution regarding the COVID-19 Pandemic and a request to follow the health advisory and standard operating procedure given by the state and central governments.
